Visa on Arrival Facility is available for passport holders of the following 150 countries:

### **Eligibility**

International Travelers whose sole objective of visiting India is recreation, sightseeing, casual visit to meet friends or relatives, short duration medical treatment or casual business visit.

Passport should have at least six months validity.

International Travelers should have return ticket or onward journey ticket with sufficient money to spend during his/her stay in India.

International Travelers having Pakistani Passport or Pakistani origin are not eligible for Visa On Arrival (VOA) . Please apply for regular Visa at Indian Mission.

Not available to Diplomatic/Official Passport Holders.

Instructions for Tourist Visa on Arrival (Enabled by ETA)

Applicants of the eligible countries may apply online minimum 4 days in advance of the date of arrival with a window of 30 days. Example : If you are applying on 1st Sept then applicant can select arrival date from 5th Sept to 4th Oct.

Recent front facing photograph with white background and photo page of Passport containing personal details like name, date of birth, nationality, expiry date etc. to be uploaded by the applicant. The application is liable to be rejected if the uploaded document and photograph are not clear and as per specification.

Tourist visa on arrival (TVoA) fee is US\$ 65/- per passenger excluding interchange charge for credit/debit cards. The fee must be paid 4 days before the expected date of travel filled by you otherwise application will not be processed.

TVoA fee once submitted is non refundable.

Applicant should carry a copy of ETA along with him/her at the time of travel.

Biometric details of the applicant will be mandatorily captured at Immigration on arrival in India.

The validity of visa will be 30 days from the date of arrival in India.

eTV is valid for entry through 16 designated Airports i.e. Ahmedabad, Amritsar, Bengaluru, Chennai, Cochin, Delhi, Gaya, Goa, Hyderabad, Jaipur, Kolkata, Lucknow, Mumbai, Tiruchirapalli, Trivandrum & Varanasi. However, the foreigner can take exit from any of the authorized Immigration Check Posts (ICPs) in India. This facility is in addition to the existing Visa services.

Tourist Visa On Arrival (TVoA) is allowed for a maximum of **two visits** in a calendar year.

Tourist Visa On Arrival (TVoA) once issued on arrival is non-extendable , non-convertible & not valid for visiting Protected/Restricted and Cantonment Areas.

### **The documents required for Tourist Visa On Arrival are :**

Scanned Main Information Page of Passport.

Format -PDF

Size : Minimum 10 KB ,Maximum 300 KB

The digital photograph to be uploaded along with the Visa application should meet the following requirements. When returning your completed application, please scan photo to us as attached jpeg file.

Format – JPEG

Size

Minimum 10 KB

Maximum 1 MB

The height and width of the Photo must be equal. (standard 2" x 2")

Photo should present Full face, front view, eyes open. NO GLASSES.

Center head within frame and present full head from top of hair to bottom of chin.

Background should be plain light colored or white background.

No shadows on the face or on the background.

Without borders.
