- Employment verification letter or student status verification letter;
- Two recent bank statements;
- Invitation letter from Slovenia;
- Fee for one entry or transit is \$26.00 dollars, multiple entry is \$52.00 dollars, checks should be payable to the "Embassy of Slovenia". PERSONAL CHECKS WILL NOT BE ACCEPTED!
- Enclose a prepaid, self-addressed express mail envelope or FedEx envelope

PLEASE NOTE: If you are only transiting, the visa of your country of destination is required.
